It is hereby declared to be unlawful and shall constitute a nuisance for any person, whether registered under this ordinance or not, to go upon any premise and ring the doorbell upon or near any door of a residence located thereon, or rap or knock upon any door, or create any sound in any other manner calculated to attract the attention of occupant of such residence, for the purpose of securing an audience with the occupant thereof and engage in soliciting or peddling as herein defined, prior to 9:00 a.m. or after 4:00 p.m. of any week day. (Ordinance #540, Section 7-1-6)
