Upon approval of this application by the Village of Albers, the applicant agrees:

1. To connect to the existing sewer main by a tapping saddle;
2. To contact the Water & Sewer Superintendent a minimum of 24-business hours prior to construction;
3. To be responsible for replacement of all street surfaces affected by said connection;
4. To be responsible for the sewer service from the main to the dwelling;
5. To provide the Village with necessary easements when his/her service main is to extend over private property not owned by the applicant;
6. To be liable for any damage he/she may incur on Village property;
7. Not to connect or permit the connection of any storm water, roof drains and/or foundation drains to the sanitary sewer system.
8. Not to use the sanitary sewer facilities for industrial sewerage without securing approval from the Village Board.
9. To remain liable for payment of any sewerage bills in the event of default by any tenant on the premises, in the same manner as if he/she were the user thereof;
10. To allow the duly authorized officers and personnel of the Village to have access to premises at all reasonable times for the purpose of inspection and repairing the sewer facilities on the applicant's premises or adjacent thereto;
11. Not to allow cross-connections of said sewerage system to other dwelling units on the premises hereinafter described;
12. To comply with all ordinances of the Village of Albers and all rules and regulations pertaining to the Village of Albers sanitary sewer system.
